TERMS AND CONDITIONS

I/We undertake to receive the documents relating to this Letter of Credit without the least delay on receipt of first advice against the payment of all drawings under this L/C local currency calculated at the rate of exchange ruling on the date reimbursement is made by you to your correspondent plus your charges and commission and in case of time draft payment to be effected sufficiently in Advance and not later than seven days prior to its maturity.
- 3. In case of failure in settlement, I/We hereby irrecoverably authorize you to debit my/our account with full value of the remaining value of documents. If balance in my/our account is sufficient to recover the same, and if there are insufficient funds in my/our accounts, you have all rights to proceed against, me/us by all means and I/We agree in advance that you have the right to put your hands on all funds, merchandise, shares and or anything of value that might be or will be deposited at your end for my/our account by way of security for the said debits and apply them instantly towards reimbursement of all your payments and expenses as aforesaid. Any debit balance on such account and any other amounts so paid when due will bear a penalty fee of 10% per annum.
- 4. I/We release Premier Bank Kenya Limited from any responsibility whatsoever regarding the correctness, genuineness, regularity, or accuracy of documents. I/We further undertake to be liable for all compensations and legal effects, which may occur as a result to errors, commissions, and belatedness of documents and or of telexes and. letters relating to this Letter of Credit sent by sellers nominated by me/us.
- 5. I/We agree to indemnify and hold the bank harmless against any claims, losses, damages, or expenses arising out of or in connection with the LC application, except for losses caused by the bank's negligence or willful misconduct.
- 6. I/We release you also from any responsibility for the Insurance Company's bankruptcy of nonpayment of Insurance amount for any reason whatsoever. It is mutually agreed that when the Insurance amount becomes due for any reason you have the right to encash its proceeds directly from the Insurance Company.
- 7. In the event where the Insurance Policy/Certificate is not required among above documents, I/We undertake to deliver same to you in original negotiable form within one week from this date against all possible risks and I/We irrevocably free you from any obligation to refer to me/us or remind me/us to effect such Insurance.
- 8. It is further understood that if such a Policy or Certificate is not delivered to you on time, or if you think at any moment that the Insurance effected and agreed upon by exporter is not for any reason whatsoever, to your full satisfaction you may without referring to me/us Insure the goods again for my/our account, (but without obligation on your part) against the risk you deem necessary and with the Company you prefer. I/We hereby irrevocably undertake to reimburse you all expenses you incur as a result.

- 9. In the event of any change or amendment with respect to (a) the amount of the Letter of Credit. (b) the time or place of shipment of any relative property i.e., goods, merchandise, relative documents securities & funds etc.(c) the drawing negotiation, presentation, acceptance of their documents or (d) any of other terms or provisions of the Letter of Credit, such being done at the request, risk & responsibility of the undersigned in all respect with regard to the credit.
- 10. I/We also understand and agree that this Letter of Credit except so far as otherwise expressly stated is to be opened in accordance with The Uniform Customs and Practice for Documentary Credits (UCPDC), 2007 Revision, ICC Publication no, 600 ("UCP").
- 11. These terms and conditions shall be governed by and construed in accordance with the Laws of Kenya, and I/We hereby submit to the non-exclusive jurisdiction of the courts of Kenya, provided that such submission shall not prejudice your right to take proceedings against me/us in any other jurisdiction. I/We understand that Premier Bank Kenya Limited (the "Bank") can decline the request without assigning any reason and that the request form will not be returned to me/us. I/We request the Bank to issue on my/our behalf and for my/our account the Letter of Credit in accordance with the terms and condition herein and the terms stated overleaf.
